THE INSTRUCTIONS FOR AUTHORS

Manuscripts in English should be delivered to the Editorial Board in electronic form, to the e-mail address <journal@gi.sanu.ac.rs> in MS WORD.

Page size: B5 (17.6 x 25 cm), top margin 4 cm; bottom, left and right margins 2.5 cm. Length of the manuscripts: minimum 6, maximum 16 pages.

Font: Times New Roman, single spaced; justified.

THE MAIN TITLE (11 pt) **bold**, CAPS LOCK, 5 blank lines from the top of the page (11 pt); the length of the title is up to 70 characters with spaces. Sub-titles of 1st order: Sentence case (11 pt) **bold**, other subtitles: Sentence case (11 pt) *italics*; All titles should be centered. The text below the titles is separated with a blank line (11 pt).

Author(s): name and surname (*italic*); if there are more co-authors; their names proceed in the same line; marked with one or more asterisks -* (depending on the number of various affiliations).

E-mail address of the corresponding author should be indicated in a footnote (9 pt) marked with number 1.

Affiliation(s) are indicated below the name of the author(s), after asterisk(s) (*)

Other footnotes are marked with ordinal numbers, 9 pt.

Abstract: bold, 9 pt, 150-250 words, no references.

Key words: bold, 9 pt, 3-5 words.

The main text 11 pt; the beginning of the paragraph is not indented. Blank line between the paragraphs. Classifications (systematic reviews) in the text should be given with indented tabulator 1.5 cm and en dash (–) (Ctrl+Num-).

References: subtitle bold, centered, 9 pt. Below, the references are written in 9 pt, justified, with one blank line between each reference.

APA citation standard is used for citing the references. Example for citing a journal article: Clark S. J, Grimm C. E, Donovan J. J, Fritz C. S, Engstrom R. D, Almendingers E. J. (2002): Drought cycles and landscape responses to past aridity on prairies of the northern Great Plains, USA. *Ecology*, 83(3), p. 595–601. Full names of the journals should be given (not abbreviations). If the reference has more than 2 authors, the form of citation in the text is (Clark et al,

2002). If there are two authors, the form is: (Carter, Jones, 1989). If the papers of the authors who have more articles during the year are used, the form is: (Stevančević, Radovanović, 2004a, Stevančević, Radovanović, 2004b, etc). Titles of the papers outside of the English speaking area should be translated into English, while the original title should be given in extension.

Table content 9 pt, formatting as in the example below. Size of the table should be adjusted to the page size. Each table should be numbered sequentially, using the regular font 9 pt. Larger tables can be placed vertically on a separate page.

Source of data:

Figures are sequentially numbered. Figure captions are written in normal font, 9 pt, aligned left. If the figure content is a photo or a map, it should be indicated in the caption; e.g. Figure 1. Photo of the Vratna canyon; or Figure 1. Map of the Vratna drainage area. Resolution for the figures is minimum 300 dpi. Clearly visible black and white version of the figures is preferred. If the color version is necessary, CMYK Image mode should be used instead of RGB. All figures should be submitted in electronic form, as particular files. Within the text, the place for the figures should be indicated.

Acknowledgements are given at the end of the paper, before the reference; left alignment.

The authors whose papers are accepted for publishing will be given a free copy of the Journal in which their papers are published.
